## Introduction

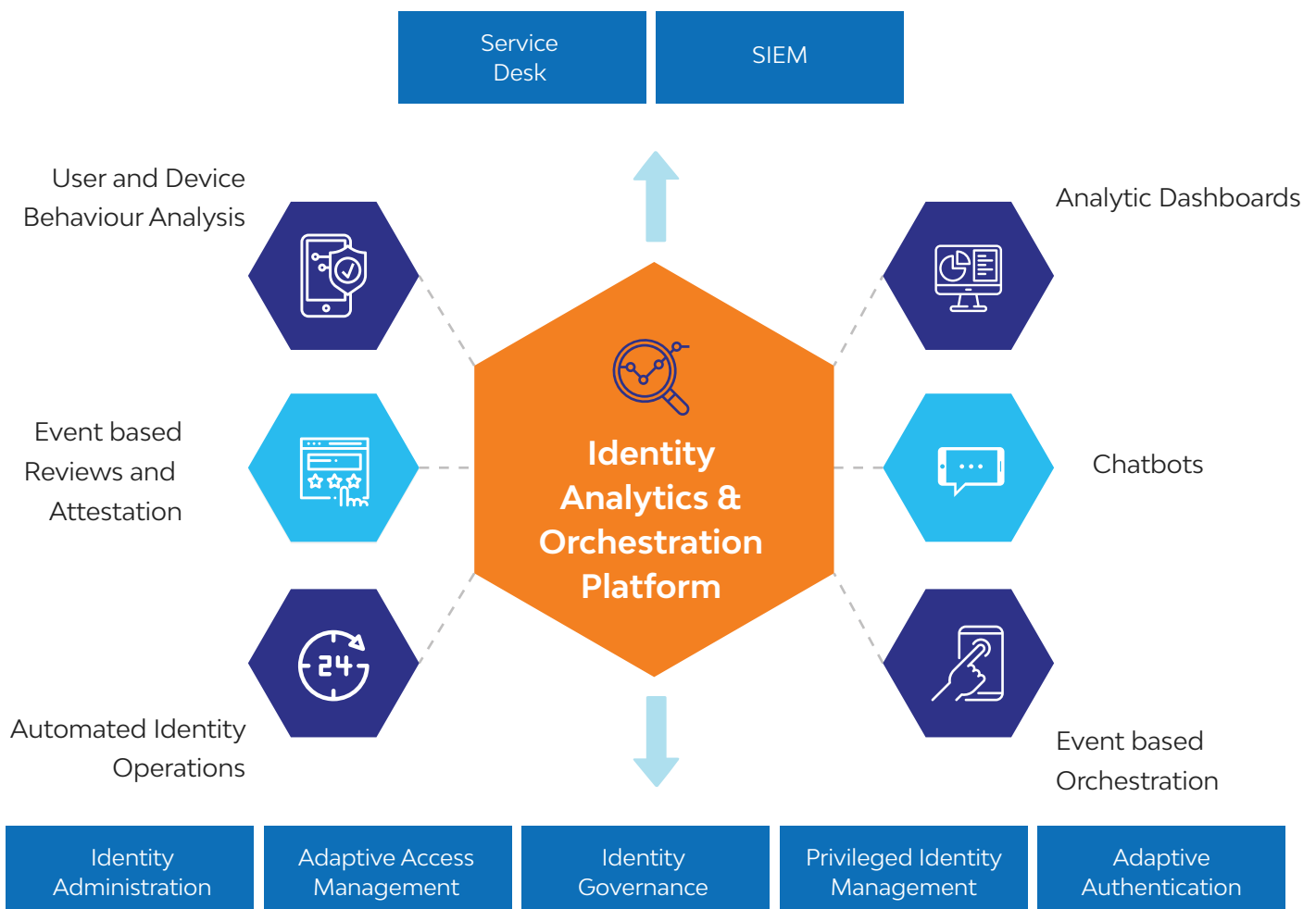
