The client is a US-based provider of loyalty and marketing services, such as private label credit cards, coalition loyalty programs, and direct marketing, derived from the capture and analysis of transaction-rich data.



## Business Challenges

- The client runs PeopleSoft 9.2 with large workloads and high infrastructure costs
- Meed for infrastructure that can handle large volumes of data (~6TB)
- Performance issues, including high latency, suboptimal server performance, and more
- Lack of a contingency plan resulting in user disruption during an event of outage
- No turnkey backup and disaster recovery plan to protect against DC region downtime/failure

Decreased operational efficiency of in-house data centers and lack of state-of-the-art security features.
