# Challenges

- Support for SAP Middleware SAP Process Integration (PI) 7.4 scheduled for a phase-out
- Choosing a suitable Integrated Platform-as-a-Service (iPaaS) solution from among SAP Integration Suite or MuleSoft
- Unmanageable growth in the number of transactions processed using the middleware platform
- Eminent adoption of new security protocols like Open Authorization (OAuth)
- Adoption of event-driven and open API architecture while continuous integration with ERP and existing designs
- Tradeoff between business priority and best practice solutions
